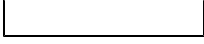

> A field test conducted today at four (4) feet below ground surface (bgs) indicated a chloride concentration of 2,290 mg/kg at the Bottom Hole 4 location.  
>  
> Therefore, I would like to amend the current work plan to allow for the installation of a plastic liner if sample concentrations are above 600 mg/ kg at 4 feet bgs.  
>  
> Six to 12 inches of sand would be emplaced at four feet bgs. The plastic liner would be installed and then soil like that removed would be emplaced to grade and reseeded.  
>
