Thank you for the revised initial C-141 with the updated GPS coordinates for the release location. The same 1RP-5121 is used. Please note that the release occurred on State surface and minerals ownership. All communications and report submittals must be send to all corresponding agencies.

Also, NMOCD visited the release location (NHGSAU 0534-33 well pad) as indicated on the first initial C-141 on Tuesday, July 17, 2018. Please be advised that any standing fluids and impacted surface soil should be removed as soon as possible, in addition to any surficial placement of pea gravel or similar absorbent.
