Olivia,

Pursuant to our conversation earlier today, please find attached the soil analysis results from the soil sample that was taken on July 5th, 2017 at the **NM 87 St #1** well in Lea County, NM. As you will note, the chlorides level decline until 8' depth (705 ppm), at which point they unexpectedly spike at 12' depth (2630 ppm). That being said, it is my understanding that this sudden increase in chlorides level at 12' depth can be attributed to the historical release that occurred under the previous operator. Primarily, we are concerned that the historic release at this site, prior to operations by Pride, may impact our characterization efforts of the recent release that occurred earlier this year. We fully understand that Section 29.8.A applies to our recent release. However, it appears that the historical release is responsible for the higher chloride levels found @ 12' depth, which overlaps the chloride levels found at shallower depths (8'), and renders the delineation margin (5'-10' below depth of 250 ppm, as requested by Mr. Griswold from the NMOCD), unclear.

Once you are able to review the attached soil analysis, please feel free to give us a call to discuss the next step in this delineation process.
