Dear Mr. Brunson:

NMOCD approves the delineation completed and proposed remediation for **1RP-5007**. Approval is also conditional based on the following:

1. Extend excavation to encompass sample locations North@Surface, South@Surface and East@Surface and provide updated site maps/figures of where resampling took place on 5/17/2018.
2. Bottom and sidewall confirmation samples from all excavation areas (SP1 sidewalls only) at no greater than 50 ft. intervals.
3. BTEX, TPH extended, and chlorides laboratory analyses for all confirmation samples.
4. Marked confirmation sample locations in relation to delineation sample locations on a scaled map.
5. Dated photo documentation of the remediation process.
