Given that there are two lab analyses provided for West@Surface and South@Surface (7/11/2018 and 7/23/2018), were the samples used for the 7/23/2018 lab analyses the same samples used for 7/11/2018 lab analyses or were they resampled at different locations?

NMOCD approves the proposed remediation for **1RP-5105**. Approval is also conditional based on the following:

- 1. Sidewall confirmation samples from all delineation sample locations, at no greater than 50 ft. intervals.
- 2. BTEX, TPH extended, and chlorides laboratory analyses for all confirmation samples.
- 3. Marked confirmation sample locations in relation to delineation sample locations on a scaled map.
- 4. Dated photo documentation of the remediation process.
