Please note that the GPS coordinates as written on page 1 do not correspond with the GPS coordinates on the figures, which indicate presumably the correct release location.

The available information indicates **OPERATOR** has met the requirements of 19.15.29 NMAC and no further corrective action is required. NMOCD considers **1RP-4875** closed. However, this determination by the Oil Conservation Division does not relieve Operator of responsibility should future information indicate a threat to ground water, surface water, human health, or the environment.
