Please note that there are unclear information provided between the tabulated data and text. For example, data in the column labeled 'Excavation Bottom (ft)' are not necessarily data from the base of the excavation, rather depth of samples taken below the base of the excavation. 'Sample depth' also was apparently used to denote both the depth of sample taken below ground surface and width of sample core. Nevertheless, NMOCD will grant closure to 1RP-4959.

The available information indicates **OPERATOR** has met the requirements of 19.15.29 NMAC and no further corrective action is required. NMOCD considers **1RP-4959** closed. However, this determination by the Oil Conservation Division does not relieve Operator of responsibility should future information indicate a threat to ground water, surface water, human health, or the environment. Furthermore, it does not relieve Operator of responsibility for compliance with any federal, state, or local laws and/or regulations.
