Thank you for your patience. NMOCD will approve of the proposed remediation plan for 1RP-3648, contingent upon addressal of the following concerns regarding the delineation report for 1RP-3648:

- 1. At what depths were samples taken on March 29, 2016?
- 2. Where is the release point (sump pump) in relation to the delineation sample points?
- 3. Submit soil bore logs and results of the EM survey, along with calibration data and colorimetric figures.
- 4. Any confirmation sidewall samples will require both chloride and TPH extended analyses due to the levels detected in March 2016.

Please be advised that any impacted soil from the release area for 1RP-3648, within stated setbacks from subsurface lines and production areas, will result in a deferral for complete remediation/reclamation at time of abandonment, retrofit, or inactivity.

NMSLO approval required. NMSLO may have additional concerns or stipulations.
