Good morning Mr. Brunson:

The submitted report for 1RP-5116 (not for 1RP-5098 as written below) does not contain all the site assessment/release characterization requirements as per 19.15.29.11 NMAC. However, to facilitate resolution, NMOCD will grant approval for delineation completion for 1RP-5116, on the conditions that all the requirements for 19.15.29.11 NMAC are provided along with the closure requirements under 19.15.29.12 NMAC.

NMSLO approval required. NMSLO may have additional concerns or stipulations. Per 19.15.29.13E, NMSLO's regulations supersede NMOCD's.
