This site is one that EPI had done a remediation plan on and it appears that they never sent a closure report. I asked BBC to look into it and they did. They visited this site and took some pictures (attached). Comparing the pictures of the leak in the EPI delineation plan and the pictures that BBC took, it appears this site was cleaned up. They even dug down to 4 feet to verify the liner was put down. The pictures do show the liner.

We are submitting a final C-141 along with these pictures that show no visible impact and hope you will consider this closed since EPI is no longer in business and we have no access to their records.
