Yes, composite samples 1-4 were taken at each inside corner of the produced water tank containment (see T3 on SPCC Plan diagram). Sample 5 was a background sample taken in the area. The deeper composite samples (vertical delineation) were taken in the same spots just deeper. I am not sure why I did not submit a site sample grid map. I looked and can't find one in the well file. This containment area had a poly liner that was about 4 years old in place at the time of the incident. FYI, this area is >100 feet to ground water according to a dry hole water well that McElvain drilled 2 years ago within a mile of this site. Let me know if you have any further questions,
