NMOCD approves of the delineation completed for 1RP-4656. For the proposed remediation plan:

- 1. The delineation data presented for the depths proposed for excavation exceed permissible levels. The area represented by SP1 and SP2 must be excavated to 4 ft. bgs; SP3 area to 3 ft. bgs; and SP4 and SP5 to 2 ft. bgs.
- 2. NMOCD will agree that no remediation is required for the area represented by SP6.
- 3. While the data for the area represented by SP7 at 4 ft. bgs exceed permissible chloride levels of 600 mg/kg for remediation, NMOCD will agree to 3 ft. bgs excavation.
- 4. Bottom and sidewall confirmation samples for each of the areas with differing proposed depths of excavation must demonstrate permissible levels of BTEX, TPH extended, and chlorides. If not, proceed to the next foot.
- 5. At least one sample location must be established at the borders of each of the differing proposed depth of excavation.
- 6. Confirmation sample locations should be no greater than 50 ft. apart.
- 7. In the remediation report, please include an appropriately scaled map with confirmation sample locations demarcated with GPS coordinates or in tabulated format.
