Cause of Release: On September 10, 2018, it was discovered that a segment on the MA-4 (Cal B Pipeline Segment) 16-inch Pipeline in Lea County, NM was causing a leak of field gas. A crew was dispatched to begin repairs to this segment. Within 3 hours the leak was repaired by using a 16-inch clamp. Given the amount of time it took to repair the leak, the leak hole size, and pipe pressure, it was calculated that approximately 134 Mcf of gas was released. Please find these calculations appended to this form.
