


<b>Describe Cause of Problem and Remedial Action Taken.*</b> Source of release is unknown due to historic nature; suspected cause is the crude oil pump station that is near the historic staining.		
<b>Describe Area Affected and Cleanup Action Taken.*</b> Historic release of crude resulted in area of asphaltines measuring approximately 50' x 200'. The impacted soil has been disposed of at an NMOCD permitted facility and clean backfill purchased from the landowner. Approximately 12,400 square feet of surface area was impacted by the release. Soil samples were collected from the excavation and submitted to Xenco Laboratories for testing. Having received laboratory analytical data from soil samples collected during remediation operations and NMOCD approval, site has been backfilled and entire area contoured to blend with existing pasture area and protect against wind/water erosion.
