Set CIBP @ 12100' and dump 35' cement on plug. Set CIBP @ 11195' and dump 35' cement on plug. Set CIBP @ 10050'. Tagged plug. Spotted 25 sx Class C Neat on top of CIBP. Perforated 4-1/2" casing @ 7020' and squeezed w/50 sx Class C Neat. WOC 4 hrs. Tagged @ 6915'. Perforated 4-1/2" casing @ 4233' and squeezed w/75 sx Class C Neat. WOC 4 hrs. Tagged plug @ 4130'. Perforated 4-1/2" casing @ 2090' and squeezed w/75 sx Class C Neat. WOC 4 hrs and tagged @ 1985'. Perforated 4-1/2" casing @ 342' and pumped 100 sx Class C Neat down casing and up to surface of 8-5/8" casing. Pressured up to 1000 psi. WOC 3 hrs. Cut off wellhead and install dry-hole marker.
