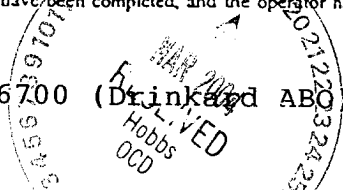

- Spot 40sx, plug from 315-Surf (Surf) Tag at Surf.
- Install dry hole marker 3-1-04.
