Ran in hole with 4 1/2" AD1 Packer on 2 3/8" plastic coated tbg. Tested tubing in hole-tested good. Set packer @ 3406'. Circulated backside with packer fluid. Rig down. Notified NMCD & ran MIT on 4/21/04. Put well on injection.
