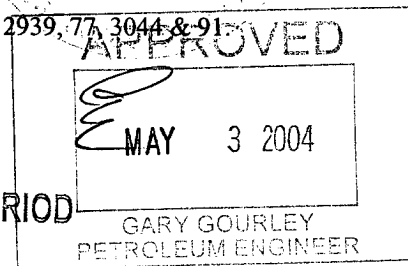
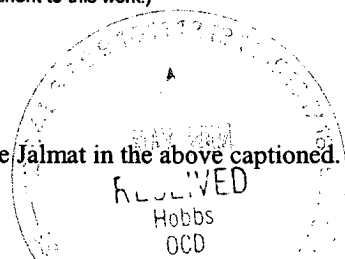

4. Acidz Jalmat perms w/ 2000 gals 15% acid.
5. Swab test.
6. Frac as directed.
7. Swab.
8. TIH w/ production tbg, Run rods & pump
9. Test well.
