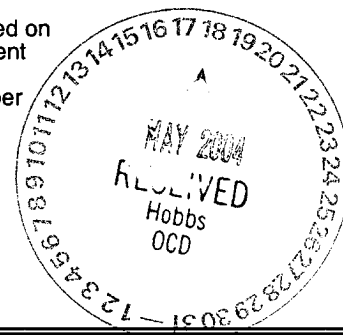

This well was drilled by Discovery Operating, Inc in 1998. Devon acquired the well as part of a lease acquisition. Devon requested to temporarily abandon the well and the sundry was approved on 06/11/03. In preparation for temporarily abandoning the well, Devon rigged up flowback equipment to bleed the well down in late June 2003. During flowback a significant volume of oil was recovered into a tank. Approval was obtained from the State for temporary oil sales for September 2003. Devon requests approval to retest the existing completion interval as follows:

1. Open tubing and csg to flow to a tank to bleed pressure off.
2. MIRU PU. POH with existing tbq.
3. RIH with bit and scraper to PBTD. POH.
4. RIH with tbq and packer. Swab/flow test current perf'd interval.
5. Treat perms as required based on flow results.
6. Place well on production.
