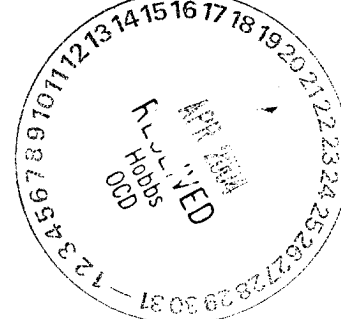

PUH & set @ 9000. Acdz perfs w/ 350 gals 15% acid. Rel RBP @ 9000. Set RBP @ 9650. TIH w/ cmt retainer to 9450. Pump 200 sks Cl "H". Dump 50' cmt on retainer. Drill out cmt & cmt retainer. Release RBP @ 9650'.
