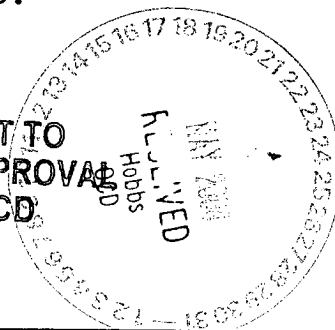

This well is currently producing 11 bopd & 13 mcfpd/ gas. The cost to install 4.3 miles of pipeline to the nearest pipeline is estimated to be \$106,000 and would not be economical. Permission to vent this gas is requested for the period May 22, 2004 until May 22, 2005.
