5. Cut 7" csg at 1000, L/D csg.
6. Spot 75sx, plug from 1050-850 (10 3/4 Shoe) WOC Tag.
7. Perf 10 3/4 csg at 250, sqz 60sx, plug from 250-150 (13 3/8 Shoe) WOC Tag.
8. 10 x Surf, install dry hole marker.
