

2. Set 4 1/2" CIBP at 3500, spot 25sx, plug from 3500-3300 (Grayburg) WOC Tag.
3. Displace hole w/MLF, 9.5# Brine w/25# gel P/BBL.
4. Spot 25sx, plug from 2400-2200 (Yates, B-Salt) WOC Tag.
5. Spot 25sx, plug from 1100-850 (T-Salt, 7 5/8 Shoe) WOC Tag.
6. Perf 4 holes at 300, Circ 65sx cmt 4 1/2 x 7 5/8 csqs (Surf) WOC Tag.
7. Install dry hole marker.
