PUMP IS CONTROLLED BY HEAD SWITCH (PUMP ON & SHUTS DOWN AT 2'). THE WATER GOES TO A SOUTHWEST ROYALTIES WELL (CITIES FEDERAL NO. 2 WELL) AND IS DISPOSED PROPERLY. NORMAL DAILY DISPOSAL IS 250 BBL/DAY
