- 1) Release RBP @ 9080' and TOH. If RBP is not easily retrievable, contact OCD and request permission to dump cement on plug to abandon.
- 2) Release RBP @ 10215' and TOH.
- 3) Set CIBP @ 10215' and dump 35' cement on plug.
- 4) Set CIBP @ 9080' and dump 35' cement on plug.
- 5) Set CIBP @ 8940' and dump 35' cement on plug.
- 6) Perforate Delaware 8672-8680' (36 holes) and 8745-8758' (60 holes), and stimulate
