

Propose to P&A well as follows:

- 1) TIH w/open-ended tubing and load hole w/9.5# mud laden fluid.
- 2) Set CIBP @ 6150' and dump 35' cement on plug.
- 3) Spot 50 sx plug 4841-4421'. WOC and tag.
- 4) Perforate 5-1/2" casing @ 2278' and place 100' cement plug inside 5-1/2" casing and in 5-1/2" x 8-5/8" annulus 2278-2178'.
- 5) Perforate 5-1/2" casing @ 445' and place 100' cement plug inside 5-1/2" casing and in 5-1/2" x 8-5/8" annulus 445-345'. WOC and tag.
- 6) Spot 10 sx plug @ surface.
- 7) Cut off head and weld on cap. Install dry-hole marker and clean location.
