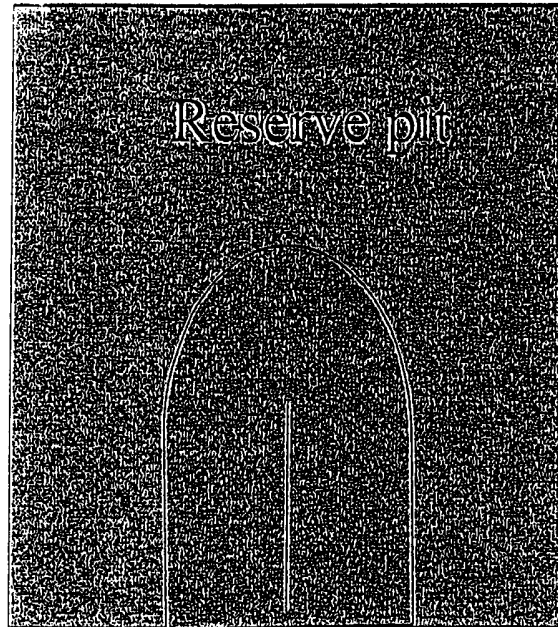

approximately 60' Southwest of the well
bore. The pit will be a 150' by 150' by
5' deep with a capacity of 20,000 bbls.
The pit will be lined with a 12 mil liner.
