As per Damian Barrett's phone call to Joe Lara (6-28-04), Henry Petroleum is asking for a 180 day extension (October 2004) to evaluate flood response as well as deeper utility of this wellbore. Henry has already shot a fluid level (D-13 depth to fluid is 2544' from surface) in this well and it is far from any fresh water contamination concerns. Henry will monitor this fluid level monthly to evaluate waterflood response. At the end of the 180 day period, Henry will either have put this well back on production (flooded zone or deeper reservoir) or TA'd it and run an MIT and reported it to the BLM.
