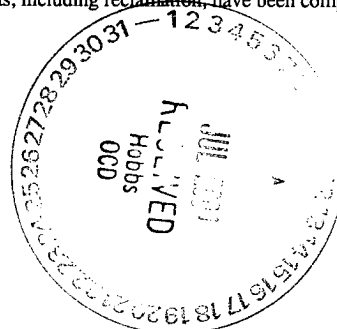

3. Circulate hole w/mud gel.
4. Set 100' cement plug from 1010-910', 50' above and below 8 5/8" casing.
5. Perforate @ 60' circulate cement to surface.
6. Install dry hole marker.
