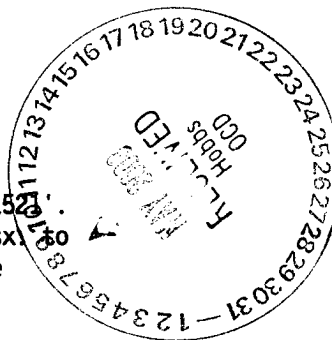

5/01/03: Run 38 jts. 8-5/8", 24#, J-55, ST&C casing with 13 centralizers and set at 1523'. Cement with 550 sx. PBCZ lead and 300 sx. Premium Plus tail. Circulate 123 sx. 80 surface. Plug down x WOC. Nipple up BOPE x test. Drill out cement and resume drilling operations.
