5. Proposed Control Equipment: A 10" 3000 psi wp Shaffer Type "E" BOP will be installed on the 13 3/8" casing and operated as a 2M system. Casing and BOP will be tested with the rig pump before drilling out with 10". Request waiver to test BOPE and the 8 5/8" casing to a maximum of 2000 psi wp in accordance with Onshore Oil & Gas Order No. 2. See Exhibit "E".

This plan is submitted with the Application for Permit to Drill the above described well. The purpose of the plan is to describe the location of the proposed well; the proposed construction activities and operations plan to be followed in rehabilitating the surface and environmental effects associated with the operations.

1. EXISTING ROADS:

- A. Exhibit "A" is a portion of a BLM Topographic map showing the location of the proposed well as staked. The well site location is approximately 36.5 road miles east of Carlsbad, NM. Traveling east of Carlsbad on County Rd #605 and NM Highways 31 and 128, there will be 33.5 miles of paved highway and 3 miles of oilfield roads.
- B. Directions: Travel southeast from Carlsbad, NM on County Rd. # 605, the refinery road, for 12.5 mile to NM Highway #31. Turn left on NM #31 for approximately 2.5 miles, and then turn east onto NM Highway # 128 for 17.4 miles. Turn left (north) onto CR-29 and continue north for 1.7 miles; turn right (east) for 1.6 miles to the Littlejack Fed. #1 well pad. The road continues east for 1.0 mile the James Fed. #3 well site. Continue east to the James Fed. #4 well pad and then turn north to the James Fed. #6 and James Fed. #7 well site. The proposed access road will start at the SE corner of the James Fed. #7 pad and run east for 1100 feet to the southwest corner of the proposed well site.

2. PLANNED ACCESS ROAD:

- A. Length and Width: The proposed access road will be approximately 1100 feet long. The proposed and existing roads are color coded on Exhibit "A".
- B. Construction: The proposed access road will be constructed by grading and topping with compacted caliche. The surface will be properly drained.
- C. Turnouts: None required.
- D. Culverts: None.
- E. Cuts and Fills: Minor cuts of 3 4 foot dunes will be required.
- F. Gates, Cattle guards. None required. One is all ready in the current access road.
- G. Off lease right of way: None required.

3. LOCATION OF EXISTING WELLS:

A. Existing wells within a two-mile radius are shown on Exhibit "C".

4. LOCATION OF EXISTING AND/OR PROPOSED FACILITIES:

- A. Harvard Petroleum Corp. has production facilities on the lease at this time.
- B. If the well proves to be commercial, the necessary production facilities will be installed on the drilling pad. A 3" poly SDR 11 oil flow line will run west parallel to the road to the James Fed. No. 7 and then south parallel to the pipeline to the James Fed. Well No. 3 tank battery, 1980' FSL & 2306' FWL, Sec. 29-T28S-R32E.

5. LOCATION AND TYPE OF WATER SUPPLY:

A. It is planned to drill the proposed well with fresh water that will be obtained from private or commercial sources and will be transported over the existing and proposed access roads

6. SOURCE OF CONSTRUCTION MATERIALS:

A. Caliche for surfacing the proposed access road and well site pad will be obtained from the location, if available, or from a State pit in SE4 SW4 Sec. 32-T23S-R32E. No surface materials will be disturbed except those necessary for actual grading and leveling of the drill site and access road.

7. METHODS OF HANDLING WASTE DISPOSAL:

- A. Drill cuttings will be disposed of in the reserve pits.
- B. Drilling fluids will be allowed to evaporate in the reserve pits until the pits are dry.
- C. All pits will be fenced with normal fencing materials to prevent livestock from entering the area.
- D. Water produced during operations will be collected in tanks at the James Fed., Well #1 water disposal well, a BLM approved disposal system.
- E. Oil produced during operations will be stored in tanks until sold.
- F. Current laws and regulations pertaining to the disposal of human waste will be complied with.
- G. Trash, waste paper, garbage and junk will be contained in trash bins to prevent scattering by the wind and will be removed for deposit in an approved sanitary landfill within 30 days after finishing drilling and/or completion operations.

8. ANCILLARY FACILITIES:

A. None required.

9. WELL SITE LAYOUT:

- A. Exhibit "D" shows the relative location and dimensions of the well pad, reserve pits, and major rig components. The pad and pit area has been staked and flagged, 500' X 500'.
- B. Mat Size: 255' X 160', plus 120' X 120' reserve pits on the north.
- C Cut & Fill: The location will require a 1.5 foot cut on all sides with fill to the center.
- D. The surface will be topped with compacted caliche and the reserve pits will be plastic lined.

10. PLANS FOR RESTORATION OF THE SURFACE:

- A. After completion of drilling and/or completion operations, all equipment and other material not required for operations will be removed. Pits will be filled and the location cleaned of all trash and junk to leave the well site in an aesthetically pleasing a condition as possible.
- B. Any unguarded pits containing fluids will be fenced until they are filled.
- C. If the proposed well is non-productive, all rehabilitation and/or vegetation requirements of the Bureau of Land Management will be complied with and will be accomplished as expeditiously as possible. All pits will be filled and leveled as soon as they are dry enough to be worked.

11. OTHER INFORMATION:

- A. Topography: The proposed well site and access road are located on top of Bootleg Ridge with the access road having a .33% slope from the west to the east. The location has an elevation of 3689 GL.
- B. Soil: The topsoil at the well site is a brown to yellowish-red fine sand to a fine sandy loam soil with occasional small sand dunes. There should be caliche at a depth of 40 to 60 inches. The soil is part of the Maljamar and Palomas fine sands land complex.
- C. Flora and Fauna: The vegetation cover has a very sparse to fair grass cover of three-awn, dropseed and bluestem, with the primary cover being plants of mesquite, yucca, broomweed, shinnery oak brush, sage, cacti and miscellaneous weeds and wildflowers. The wildlife consists of rabbits, coyotes, antelope, rattlesnakes, lizards, dove, quail and other wildlife typical of the semi-arid desert land.
- D. Ponds and Streams: None.
- E. Residences and Other Structures: None in the immediate vicinity, except oil well production facilities.
- F. Land Use: Cattle grazing.

- G. Surface Ownership: The proposed well site and access road is on Federal surface and minerals.
- H. There is no evidence of archaeological, historical or cultural sites in the staked area. Archaeological Survey Consultants, P. O. Box 2285, Roswell, NM 88202, are conducting an archaeological survey and their report will be submitted to the appropriate government agencies.






EXHIBIT "D"
