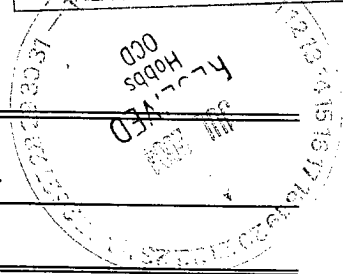
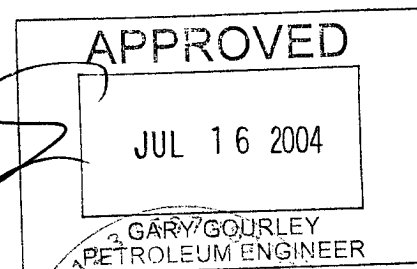

5. Perf 4 holes at 250, Circ cmt from 250-Surf w/180sx (13 3/8 Shoe) 7 x 10 3/4 behind 13 3/8 csg. Tag at Surf.
6. Install dry hole marker 7-9-04.
