

3. Spot 25sx, plug from 3800-3600 (Queen).
4. Spot 25sx, plug from 2400-2100 (Yates, B-Salt) Tag at 2139, OK with BLM.
5. Perf 4 holes at 1100, sqz w/100sx from 1100-900 (8 5/8 Shoe, T-Salt) Tag at 1014, OK with BLM.
6. Perf 4 holes at 300, Circ cmt from 300-Surf 4 1/2 x 8 5/8 w/150sx, Tag at Surf.
7. Install dry hole marker 7-14-04.
