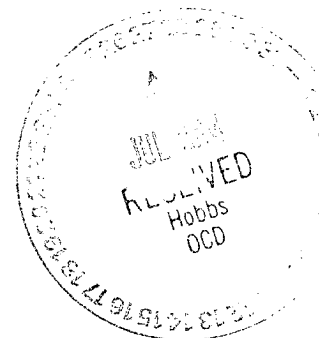
OXY USA WTP LP requests to extend the Temporarily Abandon Status Approval.
