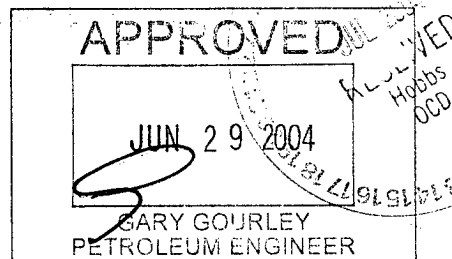

1. MI & RU CU. Drill out CIBP @ 4230'.
2. Set CIBP @ 4273' RKB.
3. Squeeze perforations from 4244' - 4270'. Drill out & test. Drill out CIBP.
4. Reperforate 4276' - 82' w/ 3 spf.
5. Acidize w/ 750 gallons & ball sealers.
6. Fracture stimulate w/ 15,000 gallons & 25,000 lbs. sand.
7. Return well to production.
8. Work is scheduled to begin 8/1/04.
