8/10/04 Ran 27 jts 8-5/8", 24#/ft, J-55 casing and set @ 1200'. Cemented w/225 sx Class C +2% CaCl +4% bentonite, tailed w/175 sx Class C +2% CaCl. Did not circulate cement. Notified Gary Wink w/OCD @ 11:45 pm and told him we would run a temp survey in 6 hours. Ran temp survey and found top of cement @ 24'. Buddy w/OCD was on location and gave approval to cement annulus down 1" tbg. Cemented w/100 sx Class C w/2% CaCl down 1", circulated 20 sx to surface.

Waited on cement 10 hours after 1" job (20 hours after primary job). Estimated compressive strength: Lead – 1300 psi, Tail – 2275psi, 1" cmt – 795 psi, for 30 minutes; held good. Commenced drilling out cement.
