8-26-04 Resumed drilling. TD 17-1/2" hole to 423'. Set 13-3/8" 48# casing @ 423'. Cemented w/220 sx Premium Plus w/additives and tailed in w/200 sx. Cement circulated. WOC. Test casing to 600# for 30 mins. WOC 18 hrs. Reduced hole to 12-1/4" and resumed drilling.
