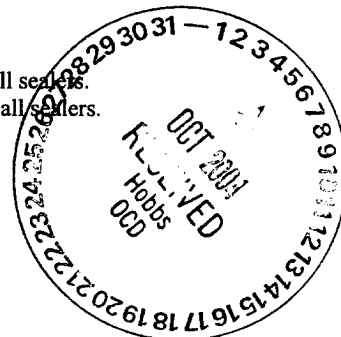

06/19/04...Perforate Wolfcamp @ 10644'-10667' (23', 92 holes). Acidized with 3000 gals 20% HCl with ball sealers.  
06/22/04...Perforate Wolfcamp @ 10601'-10629' (28', 112 holes). Acidized with 4000 gals 20% HCl with ball sealers.  
06/26/04...Test Wolfcamp perforations.  
07/18/04...Test unsuccessful. Drill out CIBP and put well back to Strawn production.
