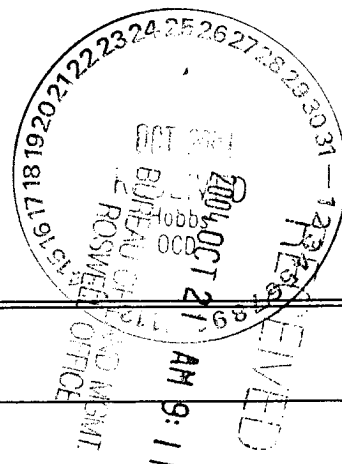

RU BJ & cmt w/Lead: 200 sx 65:35 Poz "C" + 2% CaCl2 + 1/4 pps Celloflake + 5 pps LCM 1 + 6% gel. Mixed @ 12.5 ppg, yield 1.98 ft3, mix water - 6.36 gps. Bump plug w/640 psi & circ 44 bbls cmt - 80 sx. WOC, cut conductor & prep to NU BOP.
