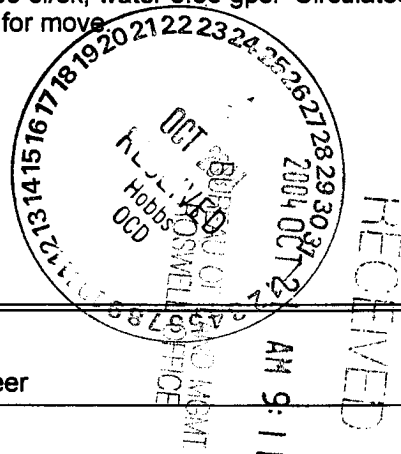

RU BJ & cmt'd with: Lead: 1,350 sx 50:50 Poz "C" + 5% Sodium Chloride + 0.25 lbs/sack Celloflake. Mixed @ 11.9 ppg, slurry yield 2.37 cf/sk, water 13.52 gps. Tail: 255 sx Class "C" + 0.1% Sodium Metasilicate + 2% salt + 0.3% CD-32 + 0.1% SMS. Mixed @ 14.8 ppg, slurry yield 1.35 cf/sk, water 6.35 gps. Circulated 100 sx. Bumped plug. RD BJ. ND BOP's. Cut-off casing and welded plate. Release Rig for move
