10-13-04 RURT and resumed drilling @ 9:30 a.m. TD 17-1/2" hole to 435'. Set 13-3/8" 48# casing @ 435'. Cemented w/240 sx Class C with additives and tailed in w/200 sx. Cement circulated. WOC. Test casing to 600# for 30 minutes. Reduced hole to 12-1/4" and resumed drilling.

10-19-04 TD 12-1/4" hole to 4202'. Set 9-5/8" 36# and 40# casing @ 4202'. Cemented w/1250 sx 35-65# "C" with additives and tailed in w/200 sx. Cement circulated. WOC 29 hrs, 45 mins. Reduced hole to 8-3/4" and resumed drilling.
