Drill 12 1/4" hole to 1135'. TD 12 1/4" hole at 0745 hrs on 9-19-04. Rig up casing crew and run 25 jts, 1128' of new 8 5/8", 24#, J55, ST&C csg. Land csg shoe at 1132'. Float collar at 1082'.

Cement w/ 500 sx BJ Lite 65:35:5, +5% salt, &2% CaCl₂. Yld--1.89 cu/ft, Wt--12.8#/gal.,

Tail w/ 200 sx Class "C" Premium Plus + 2% CaCl₂. Yld--1.34 cu/ft, Wt--14.8#/gal.

Plug down at 1530 hrs on 9-19-04. Circulated 188 sx cement to the surface. NMOC Hobbs, NM notified of running casing and cementing. WOC, Install wellhead, NU BOP. Test BOP & Manifold to 2000 psi. Drill cement and test 8 5/8" csg to 1000 psi for 30 min--OK.

Drill out w/ 7 7/8" hole at 0600 hrs on 9-20-04.
