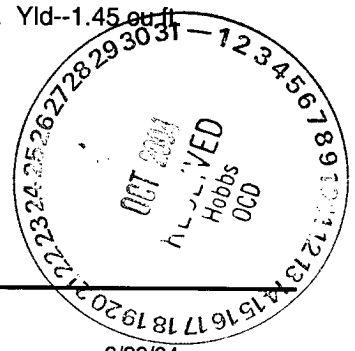

Rig up and run 97 jts, 4343', 5 1/2", 17#, J55, LT&C new csg. Float shoe at 4335'. Float collar at 4290'. Cement 5.5" production casing w/ 400 sx BJ Lite, 65:35:6 + 5# Salt, 3# LCM-1, +0.6% FL62. Yld--2.05 cu ft, Wt--12.5#/gal. Tail w/ 200 sx Class "C" Premium Plus w/ 1% FL62, 5# LCM-1, + 2% CD32. Yld--1.45 cu ft, Wt--14.3#/gal. Plug down at 0830 hrs, 9-26-04. Floats held.

ND BOP, set slips, cutoff 5.5" csg. Rig released at 1300 hrs, 9-26-04.
