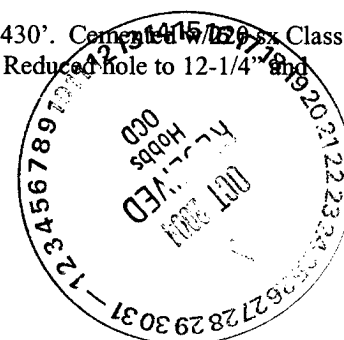

10-24-04 RURT and resumed drilling @ 5:00 a.m. TD 17-1/2" hole to 430'. Set 13-3/8" 48# casing @ 430'. Cemented w/1415/229 sx Class C with additives and tailed in w/220 sx. Cement circulated. WOC. Test casing to 600# for 30 minutes. Reduced hole to 12-1/4" and resumed drilling.
