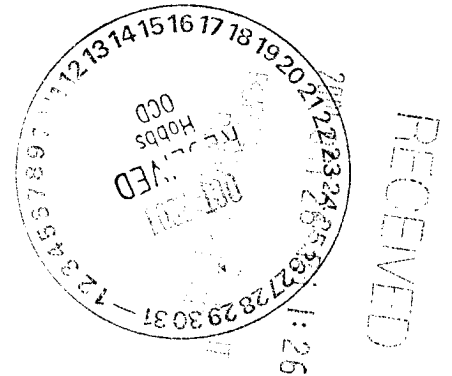

1. Oil sales by tank guage to tank truck.

2. Seal Requirements:

3. Valves 2 & 3 sealed on non producing tanks.

B. Sales Phase:

1. Valve 2 & 3 sealed on sales tank.
2. Vale 4, open & sold, then re-sealed.
3. Valves 5 sealed closed.
