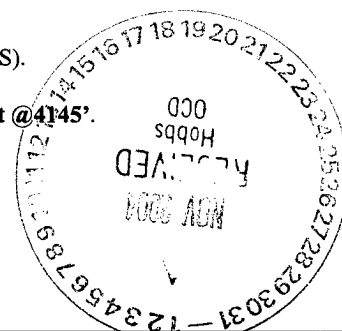

1. RUPU. Pull Injection equipment. Run 425' 4.5" 8RD FROM 3902' TO 4330'. Run CBL/CCL/GR.
2. Perforate the following intervals: 4217-30, 4247-50, and 4256-64. using 2 spf and 180 deg spiral ph. (54 HOLES).
3. Stimulate perms 4217-4264 w/1700 g 15% NEFE HCL acid.
4. RIH w/4.5" Guiberson UNI VI pc pkr, XL on/off tool w/1.875 ss "F" nipple. 136 jts 2-7/8" Duoline tbg. Pkr set @ 4145'.
5. Load csg w/150 bbl pkr fluid. Tst csg to 620 psi for 30 min and chart for the NMOCD.
6. RDPU. Clean Location.
