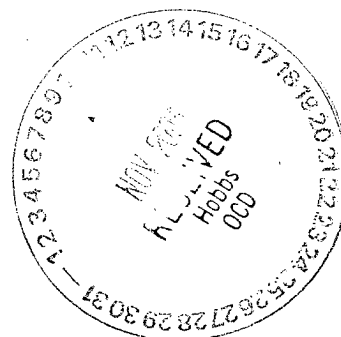

Mack Energy Corporation proposes to close plugging pit as follows:

1. Remove fluids from pit.
2. Fold liner over in pit.
3. Cover liner with 20 mil liner with excess of 3' on all sides.
4. Cover with a minimum 3' of native soil.
5. Contour pit to prevent erosion and ponding of rainwater.
