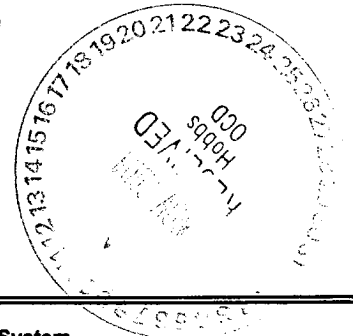

Mack Energy Corporation proposes to Deepen the BC Federal #4 to a depth of 7500'. This well currently has a 7" casing string set a 5582'. We will drill out with a 6 1/8" bit to TD, log well and run 4 1/2 casing and cement. Note: We are also requesting use of a workover pit to complete this operation.
