1. Pull production string, run bit to PBTD (4910') and test tubing to 5000 psi.
2. Perf. @ 4270-74', 4302-06', 4515-25', & 4758-84' w/4" casing gun, 2 spf 180 phase
3. Acidize in 3 stages using RBP - (1) 4758-84', (2) 4648-4715', (3) 4270-4515'.
4. Run 2-1/4" WBBL to 4600" on 4" N-80 buttress, crossover to 2-7/8" @ 4250 & hang on tubing rotator, run 2-1/4" pump.
5. Perform witnessed MIPT and return to service.
