DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Set 9 5/8" casing at 4189', using 12 centralizers, 86 scratchers and 3,040 sacks cement. Plug down at 6:30 A.M. 7-1-52. Top cement outside pipe 800' from surface.

On 7-1-52, after 48 hours WOC, tested casing with 1,000# pressure for 30 minutes before drilling plug. No pressure drop.

Drilled out cement plug from 4155' to 4190' and tested casing with 1,000# pressure for 30 minutes. No pressure drop.
